Users are responsible for leaving all facilities used, including changing areas and toilets, in a clean and tidy condition.

Please report damage caused to any of the facilities as soon as possible, either to the onsite staff member or to Louth County Council.

Users are only authorised to use the equipment and facilities they have booked. This will be specified during the initial hire agreement.

Hire slots must not over-run due to late starts. It is the Hirer's responsibility that all booking start and finish on time. If facility is used longer than the booked hire period, the hirer will be required to pay an additional fee calculated on a pro rata basis for the additional time used.

Fire action notices are located in reception and at the entrance to the hall. Please read these and ask all group members (all users) to do so.

At NO time is there to be any photos taken inside any of the rooms in the building or externally without permission.

Bowling Green

The bowling green must only be used by paid members of the public or authorized group bookings.

Bicycles are not permitted on the bowling green – please do not secure bicycles to the fence, use designated areas.

Suitable footwear should be worn at all times .

No food or hot drinks to be consumed on the bowling green.

Please report any damage or spillages.

Please do not use chalk to mark the bowling green.

Please dispose of all litter in the bins provided.

Spectators must stay outside the bowling green at all times.

No ball games on the bowling or on any green space within the facility.

Track

The running track must only be used by paid members of the public or authorized group bookings.

Athletes under the age of 16 are only allowed to use the running track when supervised by a coach or adult (aged 18 or over).

Bicycles are not permitted on the running track – please do not secure bicycles to the fence, use designated areas.

Suitable clothing should be worn at all times – boots are not permitted.

Running spikes when worn should only have 6mm spikes.

All jogging and warming up should be done on the outside lanes.

All sprints, strides and drills to be done in an anti-clockwise direction.

When crossing the running track please ensure you check both directions before crossing.

All bags and clothing should be kept in the lockers provided or if on the running track, out of the way of other users.

No food or hot drinks to be consumed on the running track – please use sportsbottles.

Please report any damage or spillages.

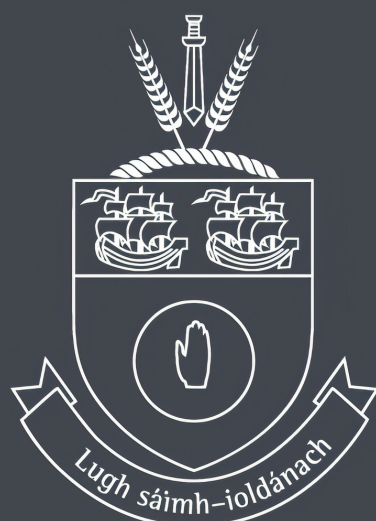
Please do not use chalk to mark the running track.
